NEWS RELEASE

On Saturday August 29, 2009 at approximately 1545 hours officers from the Northwest Regional Police Department began investigating the Robbery and aggravated assault of Cory Goldman. Goldman was found bloody and beaten on Schwanger Road in Mount Joy Township. Officer Mike Shetter found Goldman standing on the road covered in blood. When Shetter asked if Goldman was ok, Goldman told Shetter "Go get that Gold Cadillac, they just beat me up and stabbed me". Officer Shetter attempted to catch the Gold Cadillac but was not able to. Officer Shetter and other officers from the Northwest Regional Police Department then went back to look for Goldman but were not able to find him. Approximately 45 minutes later the Northwest Regional Police Department was notified by Lancaster County Police Dispatchers that Goldman was found at the Lancaster General Hospital Health Campus and an ambulance was called for Goldman. Goldman was then transported to Lancaster General Hospital to be treated for multiple stab wounds, contusions, abrasions and bites.

During the course of the investigation it was determined that Goldman knew one of his three attackers because they were former cell mates at the Lancaster County Prison. Goldman identified that individual as Eugene A. Greener w/m 18 years old from Lancaster PA. Warrants were issued for Greener. On Tuesday September 1, 2009 Greener was located in Manheim Borough and placed in Lancaster County Prison on a bench warrant. Greener was then arraigned by District Judge Duncan and placed in prison after failing to post \$50,000. bail. When Greener was picked up he was with Robert V. Holmes. Holmes was not known at that time to be a suspect in Goldman's assault however further investigation by the police showed that Holmes was involved in Goldman's assault. Holmes was placed in Lancaster County Prison on September 1, 2009 for a bench warrant. Charges against Holmes will be filed Wednesday September 9, 2009. Holmes is a w/m 31 years old from Lancaster PA.

Investigators were able to identify the third attacker as Hector T. Morales h/m 20 from Lancaster PA. Morales was arrested on Friday September 4, 2009 and placed in Lancaster County Prison by District Judge Duncan on \$25,000. cash bail. Greener, Holmes and Morales are all charged with two counts Aggravated Assault, Robbery, Kidnapping, Unlawful Restraint, Theft, and Criminal Conspiracy.

The Northwest Regional Police Department is asking if anyone witnessed this attack or has any information about the attack to notify the Northwest Regional Police Department. The investigation revealed the attack began in the parking lot of the Clearview Lanes on PA. Route 230 in Mount Joy Township on Saturday August 29, 2009 between the hours of 3:30 PM and 4PM. The attackers then left Clearview Lanes with Goldman locked inside a Gold Cadillac while they continued to beat and assault Goldman while driving on Route 230, Cloverleaf Road and Schwanger Road.
